### **Refund / Reschedule / Extension Policy**

### 1. Advance Payment

All payments must be made in advance of slot booking. A slot for the selected consultation shall only be allotted after complete payment of the service. Payment shall be non-refundable for any service. Sessions will only be confirmed once payment has been fully received and cleared.

### 1.1. Rescheduling Policy

- Rescheduling 2 weeks to 1 week before the call will incur a charge of 20% of the call amount.
- Rescheduling 1 week to 24 hours before the call will incur a charge of 50% of the call amount.
- No rescheduling or refund will be permitted in the final 24 hours before the service. Rescheduling is based on the availability of slots shared by Team Lastrological on WhatsApp.
